## **92 Voting Members Present**

### Opening prayer

Bill Steinmetz led the congregation in prayer and introduced our meeting agenda.

## Approval of minutes

Bill Steinmetz moved that the previous minutes of the June 3, 2018 Voters' Assembly be approved. Josie Ziervogel seconded the motion. No further questions. Voice vote. All in favor. None opposed. Motion passed.

### **BOD Nominations (Craig Lambrecht)**

Craig Lambrecht moved that the proposed candidates be approved by the congregation to the serve on the Board of Directors in the listed roles for the term of two years beginning in January 2019. Josie Ziervogel seconded the motion. No further questions. Voice vote. All in favor. None opposed. Motion passed.

### Summary of Amendments to Constitution and By-Laws (Bill Steinmetz)

Detailed descriptions of the amendments can be found on Hope's website under 'Board of Directors.'

#### A brief overview of the amendments is below:

- Limited the authority of the Board to be influenced by outside entities (Article VIII, Constitution)
- Updated the procedure for calling a pastor (Article II, By-Laws)
- Removed gender restrictions for holding the offices of Board Chair (Article III, By-laws)
- Modified the language regarding formation of a Long Range Planning Committee (Article IV, By-laws)
- Expanded responsibilities for each of the voting members of the Board (Article VI, By-laws)

Helen Launhardt asked if an issue occurred regarding relationships with outside entities, to lead us to this change? Bill Steinmetz advised no, and confirmed this is forward thinking as we work with vendors to expand kids ministry and build the community care center.

Bill Steinmetz answered a few minor clarification questions, such as wording and possible typos.

Bill Steinmetz moved that the proposed amendments to the Constitution and By-Laws be approved. Dave Smith seconded the motion. Paper ballots were cast. Ninety-one (91) voting members were in favor of approving the changes to the Constitution. One (1) voting member opposed. Ninety-one (91) voting members were in favor of approving the changes to the By-Laws. One (1) voting member opposed. Motion passed.

Pat noted that the salary increase is planning for one person working for half a year in the community care center.

## **Key Points**

- The 2019 budget is 1.8% higher than last year's budget. \$1,935,000 vs \$1,900,000
  - The expected revenue by year end 2018 is \$1,892,000
  - New budget will require a giving increase of 2.2 % from 2018 EYE
- Realistic from a human perspective or God's?
  - Regular giving through Oct 31, 2018 is \$1,526,965 ( 0.56% below Goal (\$8,600))
  - o "Not by might, nor by power but by My Spirit says the Lord Almighty" Zechariah 4:6
  - Praise the Lord for this!
- What if we exceed the target?
  - o 10% goes to missions
  - Will determine other options
- What if we miss the target?
  - No Salary Increases
  - o Elimination of Contingency budget line
  - Use Of Reserve Funds
  - Reduction of Expenses
