Review of December Meeting Minutes (Dave Dennison)

Dave Dennison made a motion to approve the meeting minutes from August 18, 2022. Dave D'Aurelio seconded the motion. Voice vote. 6 in favor. 0 opposed. Motion Passed.

Buildings & Grounds Status Update (Rob Pearson) – Introduced at 07:13 PM

- Performed a comprehensive review of all systems and equipment
- Established a Preventative Maintenance plan and contracted with Landry Mechanical
- Overseeing replacement of aging rooftop HVAC units and a boiler on the Greece Campus
- Reconfiguration and repair of Brockport parking and access
- Brockport Campus reconfiguration and construction work was completed on time and within a 10% budget margin.
- Core teams of volunteers are in place at both campuses for indoor and outdoor needs
- Due to legislative changes, we will no longer be able to lock in fixed electric rates after our current contract expires in December
- We are researching suppliers now to try to obtain the best variable rate we can
- Gas rate is fixed until June, 2023 and we are also researching suppliers for that
- Investigating the possible use of an IRS program called "Employee Retention Credit" that awards non-profits and business compensation for energy consumption during limited operations resulting from the COVID pandemic.

- NCAV 12.82%

HR/Staff Report (Bev) 07:41 PM

- Job offers went out this week for Comms director and worship director
- Communications director candidate has declined the offer due to theological differences
- Waiting for a response from the Worship Director candidate
- 3 of 4 Preschool positions have been filled so far
- In need of 1 more custodian
- Preschool is now back to around 215 enrolled children
- New NYS legislation prevents anyone in places of worship being armed except for police
 officers, peace officers and retired officers. Optionally, other individuals can be certified if they
 go through an extensive training class.
- Medical benefits costs going up approximately 16% in 2023

Strategy Update (Pastor Kirk) 08:02 PM

- Pastoral Call search team has been meeting regularly
- Pastor Dave Gaddini and family will be visiting Hope for interviews on September 9th and 10th
- Breakfast meeting on Saturday Sept 10 with Board of Directors and Board of Elders.

- Fall Churchwide study: Exploring Christianity, focusing on identity of Christ. Will incorporate Sunday sermon messages, follow up with teaching either in small groups or in a classroom setting
- 13 new hope groups being formed now
- June July attendance down about 6% compared to beginning of year, but this is typical seasonally
- Attendance relative to last year is up by about 5%
