- Q5. Is there access to the candidates' sermons, etc. for the congregation to view?
- A5 Yes

- Q6. Do we have specific plans for what the pastor would be doing?
- A6. Yes, we have a pastoral job description that explains that.
- Q7. Do the "open" call go to the entire seminary?
- A7. No, just the candidates that we interviewed.
- Q8. Do we know anything about the other churches that are currently calling pastors?
- A8. No.

Tim Kneeland moved to extend an open call to the seminary.

Roy Burton seconded the motion.
