Appointment of Member-at-Large to replace TJ Cappiello - 07:20 PM

TJ has left the congregation so we will need to appoint a member at large to fill his spot, under the provisions in the constitution, which allow the board to decide on a candidate to fill the position for the remainder of his term.

Tim Kneeland moved to enter into the record a resolution to appoint a person to the board of directors, under the provisions of the constitution, to fill the vacancy left by TJ Cappiello. Ross Koenig seconded the motion. Voice vote taken. 6 votes in favor, 0 votes opposed, 0 abstentions. Motion passed at 07:27 PM.

Housing Allowance: Pastor Jeffrey (MaryAnne LaRuez) - Introduced at 07:28 PM

Pastor Jeffrey has requested a housing allowance of \$42,827. Bev Janosky advised the board that the housing allowance is a dollar amount that, under IRS rules, Jeffrey is allowed to claim, based upon his own calculations and estimates of expenses. It does not constitute a grant or financial assistance from the church, but the board is required to be advised of it and to record it in our board proceedings.
