## 2024 budget (MaryAnne LaRuez) - Introduced at 12:38 PM

### **Budget Key Points:**

- Propose holding 2024 budget flat at \$2092K.
- 4% more than 2023 actual w/o special gifts
- Shifting \$ from operations to ministry / missions
- Prioritizing reaching the lost, deepening our faith and growing the Brockport campus.
- We believe a 4% giving increase is attainable in our current economy.
- If revenue target is exceeded, 10% of overage goes to missions.
- If revenue target is not achieved, use of reserve funds and reductions in expenses will be employed as necessary.
